#### Nursing Research Opportunity: Global Research Nurses Pump Priming Awards 2021

We are delighted to announce that Global Research Nurses and The Global Health Network (TGNH) have made available funds for small pump-priming grants of between £2000 and £10000 specifically for nursing and midwifery led research relevant to **Low and Middle Income Countries**

These may be used for three types of activities:

- To fund an exchange visit(s) to or from another area working on the same nursing and midwifery research project or with a view to developing a collaborative project
- To cover the costs of conducting a new small research project (typically proof-of-principle studies to facilitate further funding through other funders)
- To host a local, national or regional workshop/meeting about nursing/midwifery research with a view to subsequently developing a project
- The grant application should be for either a research project, travel or a workshop, not a mixture

### **Voices for Vaccines: Sharing the experiences of nurses & midwives to promote vaccine equity & acceptance**

On August 10th at 2:30 pm (BST) the Nursing Now Challenge, in partnership with the Sabin Vaccine Institute's [Immunization Advocates](#) program, launched a new challenge as part of its Global Solutions Initiative to elevate the voices and perspectives of nurses and midwives with the aim of influencing discussions and decisions on vaccine equity and acceptance at local, national and global levels.

This latest NNCASI challenge will run from August 10th until September 10<sup>th</sup> during which time nurses and midwives will be supported to develop an activity, using their experiences in interacting with patients, colleagues, and family/friends/community, to advocate for vaccination access and/or acceptance. As one of the most trusted professions, nurses have the opportunity and skill to influence the people they care for and the knowledge and experience to inform high-level policy decisions.

In many countries around the world, nurses, midwives, and other frontline health workers are yet to be prioritised for COVID-19 vaccinations despite the ever-growing death toll among this population and the vital role

played by frontline health workers in responding to the COVID-19 pandemic.

"Nurses and midwives deliver the majority of health services around the world and are crucial gatekeepers for families and communities to make informed decisions about vaccines and immunizations," said Vince Blaser, Director of Sabin's Immunization Advocates initiative. "As policymakers make decisions about COVID-19 vaccine rollouts and routine immunization campaigns, nurses and midwives' stories can help lead the push for vaccine equity and acceptance in all communities."

### **APS FORTE no SUS: no combate à pandemia**

Desafiados pela emergência sanitária, os profissionais da Atenção Primária à Saúde (APS) remodelaram os processos de trabalho e perceberam que muitas das inovações implantadas de forma emergencial para responder à pandemia de COVID vieram para ficar. A iniciativa APS Forte no SUS – no combate à pandemia de COVID-19 reuniu experiências de todo o País, executadas por trabalhadores da saúde engajados que, apesar das dificuldades impostas pela nova doença, lutam diariamente para melhorar a oferta e o cuidado em saúde no Sistema Único de Saúde (SUS). Com o auxílio de tecnologias digitais, as equipes e profissionais da Estratégia Saúde da Família superam diariamente um dos principais desafios da APS nesta pandemia: garantir o acesso aos serviços de saúde. As ferramentas digitais ganham força na agenda para o fortalecimento do SUS, tão bem representadas nesta iniciativa. Foram 1.471 experiências analisadas que mostraram, além da capacidade de liderança e reação rápida da APS – fundamentais para o funcionamento do SUS –, a preocupação em garantir cidadania e efetivação do direito à saúde.
